- The closing date for entries is 31 August 2021.

**Zoom meetings** will be held from the middle of September, where the entrants will be able to share and discuss their ideas. Invitations to these meetings will be sent once all entries have been received.

The winners will be selected privately by a jury and notified by e-mail. The three best entries will each win a tablet or smartphone.
